DIRECTIONS

From the NORTH via I-90/94: Take I-90/94 to the Hwy 151 exit (southwest) going toward the State Capitol. Take 151/E. Washington Ave. all the way into downtown. As you approach the Capitol Square, follow 151 from E. Washington left onto Blair Street. Take Blair two blocks and turn right onto Wilson St. A few blocks up Wilson, just past Olin Terrace, turn left into the Monona Terrace parking structure.

From the NORTHEAST via Hwy 151: Follow Hwy 151 toward the State Capitol. Take 151/E. Washington Ave. all the way into downtown. As you approach the Capitol Square, follow 151 from E. Washington left onto Blair Street. Take Blair two blocks and turn right onto Wilson St. A few blocks up Wilson, just past Olin Terrace, turn left into the Monona Terrace parking structure.

From the EAST via I-94: As you approach the city, follow Hwy 30 into Madison. Take the "State Capitol" exit off of Hwy 30, and you will then be on E. Washington Ave. As you approach the Capitol Square, follow 151 from E. Washington left onto Blair Street.
